THIS CAUSE has come before this Court on the matter of Plaintiff's, CACV OF COLORADO, LLC., Motion for Final Judgment, and the Court being otherwise fully advised in the premises, it is hereby:

ORDERED AND ADJUDGED that the Plaintiff, CACV OF COLORADO, LLC., 370 17th Street, Suite 5000, Denver, CO 80202, is entitled to judgment against the Defendant, SUSAN M.
